**JANIK'S J.D. – AN UPDATE ON LABOR/CONSTRUCTION LEGAL ISSUES**

**Lockbox Litigation Update**

In 2016, the Safe Roads Amendment (SRA) was passed. This Amendment, ushered in via a voter referendum, created a “lockbox” for tax revenue derived from gasoline sales tax and other motor vehicle fees. The intent behind the passage of the SRA was to restrict the state (or its political subdivisions) from using monies that were earmarked for maintaining Illinois roads and bridges (among other transportation related projects) for other purposes. In 2018, a group led by the Illinois Road and Transportation Builders Association (IRTBA) filed suit against Cook County claiming the County was impermissibly budgeting funds from the “lockbox” to non-transportation related line items. While MARBA was not directly involved in the litigation, the suit included other MARBA member associations in addition to IRTBA, including the CAGC, GLCA, and UCA.

The suit proceeded to trial, and the County argued it was exempt from compliance with the SRA as it is a home-rule unit of government. The case made its way to the Illinois Supreme Court. The Supreme Court rejected the County’s home-rule argument finding the SRA created no such exemption. As such, the case was remanded back to the trial court level for re-hearing on damage calculations. In subsequent hearings, the County presented the Court with a methodology that showed only a tangential relationship to transportation projects. As an example, the County argued that traffic enforcement done by the Illinois Sheriff’s department and traffic cases prosecuted by the State’s Attorney allowed for portions of its budget to be paid for by SRA taxes. Some of the items called into question as not having a transportation related (i.e. direct) purpose were toilet paper and doughnuts.

In a decision issued on January 28. 2026, Judge Allison Conlon of the Circuit Court of Cook County held the County improperly diverted \$243 million dollars in FY 2023 to non-transportation related programs. The judge’s decision can be found by clicking [here](#).


