NLRB Facing Cuts

The National Labor Relations Board has had several of its field offices leases terminated early and had members of its workforce targeted for downsizing. The termination of leases coupled with the reduction in field staff could render the agency "ineffectual" according to the Union that represents the employees of the NLRB. Over the past few months' leases for field offices in Memphis, Buffalo, Los Angeles, Birmingham, Milwaukee, Overland Park, and Puerto Rico have been terminated early. According to statistics previously released by the NLRB, it has seen its workforce decline, for a variety of reasons, by a third over the past decade while case intake has increased by 46% over that same time period. As an example, in early 2024 the Board received 1,618 election petitions compared to 1,199 the year prior. This was a 35% increase.

With the on again, off again fight with President Trump and Board Member Wilcox still hanging in the balance the "review" of NRLB operational efficiency has the potential to grind work at the Board to a halt. It remains to be seen whether the field offices that are set to be closed will be housed elsewhere or if those employees working out of those offices will be terminated and all operations in those localities will be ceased.

Executive Order Seeking to Expand Apprenticeships Issued

President Trump recently issued an Executive Order that looks to expand on apprenticeships offered. However, it appears the expansion would not be targeted on the shortage of skilled construction workers. The EO directs the Department of Labor, Secretary of Commerce, and Department of Education to submit a plan to the President which will seek to "optimize and target Federal investments in workforce development to align with the country's reindustrialization needs and equip American workers to fill the growing demand for skilled trades and other occupations." Although the EO mentions skilled trades, it seems the "other occupations" are what the Administration will focus on. Representative Tim Walberg (R-Mich) Chairman of the House Education and Workforce Committee commented on the EO after it was

issued stating it would, "expand opportunities for young Americans to get into well-paying jobs". This would seem to align with union construction careers. However, in those same comments, Rep. Walberg also criticized the Biden administration for favoring union apprenticeship plans over other, non-union apprenticeship models possibly indicating a direction on which way the EO will be implemented. Moreover, the EO targets "new industries and occupations, including high-growth and emerging sectors." In an interview conducted on Tuesday, April 29, 2025, Secretary of Commerce Lutnick discussed jobs of the future and a "new model" whereby future generations would be trained to work in factories repairing automated equipment. The AGC's director of congressional relations for labor, HR and safety, Jim Young, lauded the administration for discussing the importance of skilled trades but cautioned it is too early to tell where the administration intends to take the EO and "where they will land on this."
