Chicago and Surrounding Counties

Carpenters (MARBA) 5-31-24
(Cook, DuPage, Grundy, Kane, Kendall, Lake, McHenry, & Will)

The parties reached a five-year economic only extension in October 2023. The extension calls for economic increases of 4% each year (2024-2029).
